### IL XV COLLOQUIO BIENNALE DELL'AIDC E I NUOVI ORGANI DIRETTIVI

Si è svolto dal 31 maggio al 2 giugno con grande afflusso di associati ed altri studiosi il XV Colloquio Biennale dell'AIDC.

La seduta inaugurale, nell'Aula Magna dell'Università di Messina, ha visto oltre alle relazioni previste un fitto dibattito cui è intervenuto il Magnifico Rettore dell'ateneo messinese, prof. Gaetano Silvestri, professore di diritto costituzionale. E anche pervenuto, a testimonianza dell'importanza dei lavori e del tema affrontato ("I diritti fondamentali in Europa") un messaggio di saluto dal Capo dello Stato il quale ha evidenziato l'importanza non solo morale ma anche giuridica della Carta Europea dei diritti fondamentali approvata nel dicembre 2000 a Nizza.

I lavori delle quattro sessioni (civile/commerciale, pubblico penale/processuale penale, processuale civile) sono stati particolarmente intensi ed hanno visto oltre 60 interventi e relatori.

Sabato 2 giugno i lavori si sono conclusi con una tavola rotonda su "La formazione del giurista europeo" cui hanno partecipato i proff. Torbjorn Andersson (Upssala), Ignacio Diez Picazo (Madrid), Frédérique Ferrand (Lione), Gerhard Walter (Berna), Rodolfo Sacco e Antonio Gambaro.

A chiusura dei lavori il Presidente uscente Antonio Gambaro ha espresso il più vivo apprezzamento nei confronti dell'Università di Messina, ed in particolare dei proff. Massimo Basile e Gian Carlo De Vero, e della Fondazione "Centro di Iniziativa Giuridica Piero Calamandrei", che con i loro sforzi organizzativi e finanziari hanno reso possibile l'iniziativa.

Venerdì 1 giugno si è inoltre tenuta l'assemblea dei soci dell'AIDC, dopo la relazione del tesoriere uscente Vincenzo Zeno-Zencovich e l'approvazione del bilancio 1997/2001 e quella del Presidente uscente Antonio Gambaro, l'Assemblea ha provveduto ad eleggere i nuovi organi dell'Associazione.
